The CNY Clerk-Treasurers Association meets at various locations in central NY on the fourth Thursday of the months of February, April, June, August, and October of each year to further the cause of local government and to discuss and solve mutual problems. He'll be responsible for developing annual budgets and equipment replacement programs, overseeing the operations of the waste water treatment facility, managing the

union labor force, planning and forecasting projects involving the village infrastructure and numerous maintenance activities that occur throughout the year. The Village looks forward to welcoming Bob to its staff.

#### **Village Office Moves to New Location**

Village of Groton Clerk-Treasurer/Administrator Chuck Rankin reported that the Village of Groton Clerk-Treasurers Office moved to a new location on October 24, just up the street from where they were. The building purchased for the office is a former Kingdom Hall of Jehovah Witnesses and contains about 4,000 square feet of space, about four times what they had available to them in the Municipal Building. The Code Enforcement Office has also moved to this new location. The Village held an open house that was attended by many citizens and the village staff.

#### **Grant Awards Received**

The Village of Clyde recently announced that they have received three grant awards during the past year. A Transportation Enhancement Grant for their downtown streetscape for a total of \$628,000 as well as \$392,000 grant award from the Federal EDI Program with the assistance of former Congressman Walsh. New street lights and sidewalks are being planned for the spring of 2009. In addition, a \$378,000 Small Cities Drainage Grant was received and is also scheduled to begin in the spring.

It is a very nice space, and I think it meant a lot to staff that we took the time to go. We had two very long days. The first was spent on strategic planning. We started this in Atlanta in May, and it will continue for another year or so, until we feel that IIMC is on the right track to take us all into the next decades. At the end of the day, we started part of the Board meeting; knowing that we could not get everything done the next day. We did the Executive Director's evaluation. On Saturday, our Board meeting started at 8:00 A.M. and lasted until about 6:30 P.M. We passed the budget for 2009, which, unfortunately, includes a small dues increase. ### NYSACVC Registered Municipal Clerk (RMC) Program

The RMC Program is administered by the NYSACVC and by the New York State Town Clerks Association. The program was established to recognize educational and professional accomplishments in preparation for a municipal clerk career. The program serves to promote the continued education of municipal clerks to enable clerks to better serve their boards and communities.

The RMC Program was designed to be consistent with numerous certification programs currently established in other states. The benefits of the RMC Program include but are not limited to the following:

- 1. Elevate the skill level of clerks;
- 2. Promote the image of the clerk's profession;
- 3. Enhance performance and status of the clerk;
- 4. Ensure the public that a clerk who has obtained the RMC designation possesses a minimal level of competence;
- 5. Enable clerks to make their skills more marketable;
- 6. Promote the formation of a professional identity;
- 7. Foster agreement on basic values, ethics and norms of conduct

The RMC Program requires that all applicants achieve a total of 50 points in each of two categories – education and experience. Applicants must also endorse the Code of Ethics for clerks and fulfill other requirements for certification. Applications for the RMC Program may be obtained from the RMC Committee Chair or from any of the Executive Committee members. In addition, scholarship funds are available.



Some general topics since our last Bulletin was published include:

#### **AIM Funding**

Under the Governor's current plan, most cities and villages would receive the same amount of AIM funding in 2009-2010 as they did in 2008-2009.

#### **CHIPS Funding**

The Executive Budget proposal will reduce CHIPS funding by a total of \$122 million, or 31%, year to year. Local governments are responsible for 85% of New York's roads, highways and bridges.

#### **Bidding Thresholds**

Proposal to increase bidding thresholds for local government procurement from \$10K to \$20K for purchase contracts and from \$20K to \$50K for public works contracts.
