Speaking of tourism, our region, which includes the Adirondack Park, is home to some wonderful vacation destinations. Lake Placid, familiar to many of us who have attended Fall School, is bustling with activities in the summer. August events include weekly sinfonietta performances, a lacrosse tournament and figure skating shows and training. • Village of Weedsport Treasurer Diane P. Scheufele was very pleased to report that the Village of Weedsport will receive American Recovery and Reinvestment Act (ARRA) funding for an updated wastewater treatment plant. The Environmental Facilities Corporation Board of Directors approved the first round of economic recovery projects and formally announced the ten ready-to-go projects in their April 14, 2009 letter. They

wrote: "Village of Weedsport, Cayuga County – Project Cost: \$6.1 million; Hardship Loan = \$3,050,000 @ 0% interest/ Principal Forgiveness = \$3,050,000. ARRA funding will support the planning, design and rehabilitation of the Village of Weedsport's sanitary sewer system and for construction costs associated with upgrading the community's wastewater treatment plant. During wet weather events, the wastewater treat-

ment facility receives too much water to treat; this project will mitigate that water inflow and infiltration and ensure compliance with all environmental permits." Treasurer Scheufele recognized the project's approval as great news for the small community and said it's estimated that it will save their taxpayers over \$5 million in interest payments.

• The Central NY Village Clerk/Treasurers Association held their annual alumni meeting at Justin's Grill in East Syracuse on June

25, 2009. Twenty-one people attended including retirees Carl and Mary Kimberly, Susan McNeill, and Carolyn Burgess (McGraw), Carl Sterling (East Syracuse), Marty Lynch and Sally Dickson (Fayetteville), Sally Eick and Jeanette Horner (Elbridge), Theresa Vincelette (Chittenango), and Anita Jebbett (Homer). Each of the retirees reported on their activities and it was very apparent that none of them have trouble filling their days with hobbies, charitable work, and spending time with family and friends.

• I would like to thank everybody from Region 5 (Allegany, Cattaraugus, Chautauqua, Erie, Genesee, Monroe, Niagara, Orleans & Wyoming County) who have shared various items of concern and question throughout the past year. I hope you continue to reach out to each other as we are all in this together.

• The Village of Barker (Niagara County) has received a Community Development Block Grant – R for a waterline replacement. This will be funded with the Economic Stimulus Funds for \$743,491. If you plan to visit the Village Barker on Thursday Nights, make sure you stop by the Farmers Market located in the Village Park on Main Street from 5:00 PM – 7:30 PM.

• The Village of Orchard Park (Erie County) celebrated a number of events in the village this summer including "The Taste of Orchard Park", Ice Cream Social and Fireworks, Street Dance with the Boys of Summer along with an Antique Car Show. The Orchard Park Council of the Arts sponsored weekly concerts on Sunday's, Tuesday's and Thursday's at 7:00 PM from the beginning of July to the beginning of August. The Orchard Park Jaycees will be sponsoring the Quaker Arts Festival in September at the Orchard Park Middle School.

• The Village of Sloan's (Erie County) emergency response team is introducing the national program File of Life (FOL). This program was initiated in 1995 and is in use in over 12.5 million homes throughout the country. The program is voluntary and is designated to assist EMS, police, and fire when responding to an emergency call. The resident is issued a packet that includes a sticker for their door indicating that there is medical information in a magnetized pouch on the refrigerator and in their wallet. For more information, please see the FOL website - www.fileoflife.org • The Village of Corfu (Genesee County) has been awarded a \$1,035,404 grant through the American Reinvestment and Recovery Act (ARRA) for the Village Storm Sewer Improvement. NYS Community Development Block Grant Program will administer this.

• The Village of Angola (Erie County) is working on the Herman Park Enhancement Project installing a shelter, bathroom and walking path around Herman Park, which rests at the foot of Big Sister Creek. They are also in the process of stream bank stabilization efforts for the Big Sister Creek Bank. People, Inc and the Department of Housing and Urban Development are in the process of constructing 29 senior housing units on Main Street and should be completed by the spring of 2010.

• I look forward to seeing many of you at the 54th NYCOM Fall Training School at the Albany Crowne Plaza from September 21 – September 24, 2009.

• We are already planning for Christmasville - The Village of Lancaster, with the assistance of the Lancaster IDA, are purchasing the old M&T Christmas figurines in connection with Christmasville (they were previously owned by The Lancaster Opera House).

• The Village of Lancaster Community Development Corporation is holding "The Amazing Race" on September 26th to benefit local business-

IIMC UPDATE

Annual Conference Review/Region 1 Update

A strong contingent of Clerks from across New York State attended the 63rd Annual Conference of the International Institute of Municipal Clerks (IIMC) May 19-23, 2009 in Chicago, Illinois.

On Wednesday IIMC's 11 Regions held separate meetings. Our Region I Directors, Linda Cohen of Maine and Bernice Dixon of Connecticut, reviewed the activities of IIMC during the past year. Jim Mullen, Town Clerk of Milton, Massachusetts was introduced as our incoming Region Director, replacing Linda whose term was expiring. Thank you to Linda for a job well done. Concerns were raised about the slow pace of receiving certification status from IIMC. Reports were presented by representatives of the New England Municipal Clerks Institute and Academy at Plymouth State, New Hampshire and the Cornell Municipal Clerks Institute and Academy at Cornell, New York. Region I went on record as being opposed to the decision by IIMC to grant 8 education points to those individuals who attended the Chicago Conference. Previous conferences awarded a maximum of 4 points. Many opinioned the 8 points was simply a way of increasing attendance at the Chicago Conference and had little to do with earning gualified education points. During the Annual Business Meeting several Clerks outside of Region I also expressed their displeasure with this practice. The IIMC Executive Committee stated they would review this matter.

A major issue that surfaced during the conference was a proposal to present several constitutional amendments for approval at the Annual Business Meeting. A small article on page 15 of the March 2009 News Digest provided a brief outline of the proposed amendments. The article; however failed to provide specific language for three of the four amendments and did not indicate the author of the amendments as required by the IIMC Constitution. As an alternative, the IIMC Constitution also provides for posting proposed amendments prior to the start of the Annual Conference. This was not done. These procedures are specifically spelled out in Article XIII of the IIMC Constitution and required as part of the approval process. Without proper notification to the membership or posting of the proposed amendments, constitutional amendments cannot be considered. After several conference attendees, including this author, advised IIMC the proposed amendments did not meet the notification threshold of the Constitution, a concerted effort was made to find fault with those who brought the issue to light and brand them as troublemakers, instead of

addressing the notification problem itself. One person stated this was a phony issue and merely a plan to disrupt the Annual Business Meeting by embarrassing certain individuals. Another wanted to ignore the notification problem and proceed with voting on the proposed amendments as planned. This would have been a violation of our Constitution. The fact is a mistake was made in how these amendments were proposed. Ironically, the proposed amendments themselves were not controversial. The process; however was irreparably flawed. The lesson here is simple, if we as members of IIMC choose to ignore the facts and do not follow our own Constitution, how can we, as Clerks, expect the public to do the same when it comes to the municipal codes, rules and regulations we are sworn to uphold and enforce in our own municipalities?

After some discussion, the IIMC Board of Directors appropriately withdrew the proposed amendments from the Annual Business Meeting Agenda.

Next year's Annual Conference will be in Reno-Tahoe, Nevada, May 23-27, 2010. I encourage everyone to attend an IIMC Conference. To meet Clerks from around the world in an excellent educational and social atmosphere will be an experience you will find memorable and worthwhile.




Cornell Municipal Clerks Institute

Some general topics since our last Bulletin was published include:

Consolidation

The proposed consolidation bill (Assembly Bill# A8501 / Senate Bill# S5661) that was drafted by the Attorney General's Office, and which was the topic of much discussion over the past few months was signed into law by Governor Paterson in June. The New York Reorganization and Citizen Empowerment Act, commonly referred to as the Consolidation Law is scheduled to go into effect in early March of 2010. There have been on-going discussions regarding making amendments to the law but to date none have been announced. This topic is of major importance to all Villages and will be monitored closely in the months ahead.
